- My daughter was honored here tonight and I do appreciate it. I have three children in Glen Cove schools. Isabelle in 5th grade, Ryan in 9th grade and Anna in 8th grade who was honored this evening. Tonight I would like to offer my public support for the Glen Cove teachers association. I attended the middle schools spring concert last night. My wife and I both marveled at Anna's orchestra teacher, Mr. Chris Lippe. The performance was flawless and beautiful. Afterwards, I thought how is it possible that this man is working without a contract. Ms. Wolf, Roland, Pilewski, Stanco, Incerto, Brunhuber, Eisle, Rubin, Schmidt, Hall, Gielbeda, Blackherd, Linden, Bannerman, McGahan . These are just a handful of teachers that my kids have had over the years and all of them are working without a contract. I'm speaking as a taxpayer and a parent. Please settle the teacher's contract. Glen Coves district has more of a community feel than most other districts. We've seen it tonight, yet the message you send is that you're not willing to take care of your own. How can this be? Please settle the contract. Our teachers belong in the classroom before school getting ready for their day not on the drop off line fighting for dignity and support for their own families. We must do better by them and for our community. This is a tough enough time in education with so much better influence than going against public education. We need to control what we can. Support our teachers and community and settle the contract now. Thank you for listening.
- I didn't plan to mention this for the rest of the this school year. I have mentioned it at least once or twice for the last eight years. At meet the candidates night one of the candidates brought up this issue although she has never ever said thank you we should really do something about that, I'll talk to my fellow board members whoever they may be. This has to do with what can and can't be discussed at executive session under the open meeting regulations of the state of New York. I am aware that lawyers who represent the school board have educated every school board in the state of New York.
