Superintendent's Report - Updates

GCSD – Update of Distance Learning — Dr Michael Israel gave an overview presentation as to the process of the distance learning as well as the schedule and how it was working. It was also mentioned how the different learning was taking place at all the different levels which included packets at the elementary level; iPads for the 4th and 5th graders; and the 1-1 initiative for 6-12 graders. Board members expressed their concerns and questions all of which were addressed.

Budget 2020 – 2021 Ms. Victoria Galante presented via PowerPoint presentation going over the budget components reflecting the 10% reduction in state aid. The Board asked questions as well as requested information, all of which were addressed.

Dr. Maria Riahna mentioned the as we look at the budget situation for the 2020-2021 school year with our budget being voted on in May. This year because of the pandemic and the changes based on the executive order it will be a budget vote on June 9th will be done by mail. Every registered voter will be provided with a ballot that will be going out shortly and they have until 5pm on June 9th to be able to return that ballot to Thayer house. There's self- addressed stamped envelope provided. It's an unusual way of doing things but it's been a directive based on the Governor's request through executive order and Ida Johnson and her staff have been working diligently to make sure that we abide by all timelines and notices and I thank her. All voting information is on our website and we wish good luck to all four of the candidates. Questions were addressed regarding the counting of ballots.

- It is noted that Trustee Karen Ferguson is not in agreement with the requirement
 of four other members of this unit needing to participate in order for this to move
 forward.
- President Gail Nedbor-Gross also doesn't agree with the need to have a minimum.
- Vice-President Monica Alexandris-Miller is on record saying that it is not our place to override the agreement between the units and the administration. It is not their place to tell the units what they want therefore that is what we should go with and that it is her understanding that it is a memorandum of agreement.
- Trustee Karen Ferguson commented that it's not what the unit wanted it was a requirement from the district to have the incentive.
- President Gail Nedbor-Gross clarified that no one has agreed to this we are the first to agree to this and then we go to them for further agreement. We're the initiator of this.

Dr. Maria Rianna clarified that administration has spoken to the three unit heads. President Gail Nedbor-Gross stated that they may be aware of it but they have not come to an agreement.

- Vice-President Monica Alexandris-Miller stated not to be misleading (it was hard to understand Monica's audio at certain points of the conversation).
- Trustee Karen Ferguson requested point of clarification as to who signs the agreement? BOE President or the superintendent?
- President Gail Nedbor-Gross responded that she signs it upon the majority of approval.
- Trustee Karen Ferguson stated that we're a significant body to decide whether this is how we want to present it. We do have a right to an opinion? We're not interfering with business and we as board trustees are going to have our names attached to this. If we don't think that we want to have a requirement we'll four members of this body to decide if they'd like to take that position. I'm standing strong on mine.

New Business

President Gail Nedbor-Gross wanted explained that while some parks are opening our school buildings are still remaining closed.

Dr. Maria Rianna replied that due to us not being a public parks and social distancing guidelines. Disappointment that someone broke the gate to the track and we're working on locating this hard to find piece to fix that and someone also tampered with the tennis courts cutting through the fences crawling under the fencing to get onto the courts. The nets were removed as we noticed more than ten people on the courts. We're concerned as we're not a public park and being very cautious at this time. Thanked the community for their support and understanding. Thanked those that have contributed to our school pantry. Nassau County came in last week and did a food drive where we served about 1500 cars in a matter of 2 ½ hours. Many of students came to volunteer under the direction of a supervisor. Each week we have people at our high school and middle school pantries either delivering food or donating food and manies. Her heart goes out to for all the time and effort in supporting other members of the community.

Trustee Karen Ferguson asked what's the procedure for utilizing the grounds as there were a number of kids on the back Deasy field playing soccer.

Dr. Rianna replied that our playgrounds and fields are closed. We don't have sports going on for that same reason and we don't have weekend security to move people out and some of our staff if they see this they to break it up. Social distancing is very important and is working.

President Gail Nedbor-Gross asked if an update on moving up ceremonies could be addressed.

Dr. Rianna responded by saying that we're still finalizing what we can do and hoping for a lifting on some of the restrictions by Nassau County or the Governor. We will have recognition commonies and parents will be given that information as soon as it's finalized. It will also be posted on our website for any community members that don't have kids in the district.

Trusce Lia Leone thanked the teachers for being rock stars. Thanked TA's, lunch monitors, custodial staff.

Dr. Rianna followed by saying that everyone has been amazing when it comes to food distribution, teachers coming in assisting students with personal items. Everyone in the district has been amazing. Newsday has a list of Long Island's list of valedictorians online today and ours is shining bright. Congratulations to our valedictorian, solitarian and all the children in our senior class. We will continue to recognize them and have some nice things in the month of June.

President Gail Nedbor-Gross reminded everyone of the budget hearing scheduled for May 27th at 5:00 pm.
